17 Opening Bank as per Accounts. Forecast Closing Bank December 2020 drops to £5.4K, reduction in bank as less fund raising in 2020. Ideally bank would not drop below £5000.

The presented budget is a prudent forward view of the next 2 years, concerts have recently proved more popular and generated greater income, and expenses are generally less than budget.
